LENT, HOLY WEEK AND EASTER

It is easy to think of Lent, Holy Week, Easter and the other Church Festivals as annual commemorations of something that happened a long time ago, but which do not seem to have much significance for us in our modern world. To think like this is to miss the whole point. The great events which happened to Jesus, Who is God, happened once in the history of the world, but they happened for all time. He still comes to us on our Altars just as truly as He did to Mary in Bethlehem; He still chooses His friends, who still misunderstand Him; He is still betrayed by those who call themselves His followers; we still forsake Him when trouble arises or our personal comfort is at stake; He is still denied by Peters who are afraid to speak out for their Lord; He is still beaten-up by the sins of the flesh; He is still crowned with the thorns of our evil thoughts; people who sing His praises one day are still ready to shout "Crucify Him!" the next. There are still those who doubt His Resurrection, and still those who fall at His feet and cry, "My Lord and my God."

What the Church asks you to do is to contemplate this drama of God's dealing with Man, and to interpret it in terms of your own personal life in this present age.

You are asked to go with your Lord in Holy Week and on Good Friday—not to the pictures, or on holiday, or to sit comfortably by your televisions; but to go with Him to His Death. Not very pleasant, but still that is what a Christian should be prepared to do. "If any man would come after Me, let him deny himself, and take up his cross daily, and follow Me."

Ask yourselves where you would be if the terrible tragedy happened today, and be honest with yourselves when you try to answer; for the tragedy is happening today and we are all taking our part in it. It is to help us to see where we are and what we are that the Church gives its people the opportunity of Lent, which is a testing time.

There will probably be many worshippers in Churches all over the country on Easter Day, and the Easter Alleluias will be shouted loud and long, but they will be hollow Alleluias (as hollow as the Hosannas on that first Palm Sunday) if they do not come from a sincere heart, and you cannot sincerely and devoutly keep Easter if you fail our Lord and Master on His Day of Suffering.

MARRIAGES IN LENT

The Bishop of Oxford, writing in the "Oxford Diocesan Magazine," has made some suggestions to the diocese about the celebration of marriages in Lent, a subject on which his advice had been sought by some of the clergy. As custom varied a good deal, he offers suggestions (and not directions) towards a more uniform policy.

Dr. Carpenter says: "We cannot refuse to marry people in Lent, and it must be recognized that there are sometimes good and respectable practical reasons in particular cases why the wedding should take place in that season. Financial inducements, relating to income tax, are responsible for some of the weddings in March or early

April, and there are sometimes other reasons, such as the availability of a house or the obligation to take up

an appointment at a certain date.

To most people who ask for a wedding in Lent, even if they are regular members of a congregation, it probably comes as a surprise to learn that it is an unsuitable request. They are not asking for something which they know beforehand to be unusual. We can hope for some understanding of the point when we are talking to faithful parishioners who normally do something to observe Lent; others are unlikely to see the point at all since Lent means nothing to them.

"There is no reason why the unsuitability of their proposal should not be pointed out to any couple proposing a Lent wedding, but if after discouragement they persist, I do not think any useful purpose or principle is served by insisting as is sometimes done that the ceremony must be reduced to its barest essentials. After all, apart from Holy Week, we observe Festivals of the Church which fall in Lent, and we do not banish music from our Lenten services. I should not myself deny

music at a Lenten wedding if it were asked for.
"The ringing of bells perhaps falls into a different category; it would be no hardship to make a rule that bells are not rung for Lenten weddings. Having said this, I should, however, suggest that for the question we are considering, Holy Week stands apart. People are more generally aware of its meaning than they are of Lent. In Holy Week we keep no Festivals and all the services are directed to our Lord's Passion. If in the last resort a wedding must take place on any day in Holy Week, it seems to me reasonable to insist that the service shall be as simple and unadorned as possible.'

THE ENTHRONEMENT OF THE BISHOP
