THE VICAR'S LETTER

My dear People,

Are we at the outset of a new era of Church Reform? The last one was in the eighteen-thirties. It was not a spiritual movement, but the overhaul of the machinery of Church organisation made it possible for the great spiritual movements of the nineteenth century to energise the Church of England without overstraining the frame.

If anything is done to implement even a few of the reforms suggested in the Paul Report on the employment and deployment of the clergy, the outward shape of the old C. of E, will 'suffer a sea change', certainly into something strange, whether rich as well is a matter of earnest debate. But the mountains are still in labour with this one, and it remains to be seen whether they will give birth to mouse, monster or masterpiece. Let us take a look at an infant that has just actually come to birth.

In March a special meeting of the Worcester Diocesan Conference gave final approval to certain resolutions setting up a system of synodical government in our diocese. The new arrangements will come into force later this year.

The main idea is to give the people in the parishes a bigger share in the administration of the diocese and much more direct contact with the bishop.

Instead of the present ruridecanal conferences, which consists of a few representatives from each which consist of a few representatives from each to the dioese or parishes, there will be ruridecanal synods, to which all parochial church councillors will belong. They will debate matters referred to them by the bishop, or which they wish to bring to the attention of the diocesan conference. Furthermore these ruridecanal synods (and not the diocesan conference as before) will elect the members of the various boards, councils and committees which assist the bishop in the administration of the diocese.

As the ruridecanal synods will meet on different dates, it is hoped that the bishop will frequently be able to attend them in person, so as to consult with the representatives of the Church in each locality. If he is not present, the archdeacon will be there.

That is the system in brief. It is not by any means revolutionary. Nor is Worcester the first diocese to attempt synodical reform. But it is a step in the direction of more effective representation in the councils of the Church and a closer liason between the bishop and his flock.

The ruridecanal conference was always the weakest link in the chain of representative government set up for the Church of England by the Enabling Act of 1919. The chief reason for this weakness is that it neither legislates nor administrates, and has no power of the purse. Money is raised in the parishes and spent by them or the diocesan conference or Church Assembly. The poor r.d. conference is left with nothing to do except invite speakers to address it on European cathedrals or "Why I belong to the Church of England".

If the movement in the Church of England towards grouping of parishes, to be served by a team of clergy, continues to increase (as in envisaged in Mr. Leslie Paul's report), the rural deanery is going to be a far more important unit than hitherto. It is right therefore that there should be a more effective organ of ruridecanal representation in the affairs of the Church than the present r.d. conferences. It is clear too that if the Church of England goes forward to closer unity

with the Methodists, the movement for synodical government will gain great impetus under Methodist influence. So far the Church Assembly and Convocations have failed to accept the principle of truly synodical government at the top. Perhaps the movement from below, if it catches on in the dioceses, will sweep (or seep) its way into Church House.

Incidentally, our own joint meetings in Badsey and Wickhamford on Anglican-Methodist relations, including two very cordial and helpful meetings with local Methodists, have been a fruitful experience to those of us who took part. I shall report on these conversations when the P.C.C.s have given their answers to the Bishop's questions.

ANNUAL CHURCH MEETING, March 18

It was ironical that after deliberately making the meeting later in the year, in view of the experience of last winter, we should have run into a spell of wintry weather, and it cannot be said that aftendance was good. Mrs. Cooke reported that the Electoral Roll now stood at 145, an increase of 13 on last year. In her review of the work of the P.C.C., she referred to the visit of Mr. Hook, Diocesan Secretary, the social evening for the newly confirmed and their parents, the successful harvest supper, and the Christmas Bazaar. Mrs. M. Jones presented the accounts, showing balances of £58 in the General Fund and £94 in the Fabric Fund, a decrease of £159 on last year's total balances. The final account for the earlier repairs to the church had been paid during the year. The Diocesan Quota this year would be £132.

Encouraging reports on the work among children and youth were given by Deaconess Caroline, Miss A. Cox and Mr. M. Jones. The Sunday School numbers 40, and Miss Cox spoke highly of the co-operation of the parents, and of the keen initiative shown by some of the older pupils in running little efforts for Sunday School funds. Deaconess commented on this same keenness in the Junior Club, and in the children's presentation of the nativity play. Early in 1963 she had started the Youth Club, and the parish was truly blessed in having in Mr. and Mrs. Michael Jones and Miss Margaret Willis a team of laypeople who had taken over the responsibility of running the Club, and very successfully too. This had enabled her to concentrate on the pastoral and educational side with young communicants and others. Mr. M. Jones reported that the Youth Club was now completely self, supporting with a membership of 48 and a weekly attendance of 30. Activities had included a visit to the Beatles at Cheltenham.

The Vicar expressed appreciation of the loyal cooperation of fellow workers. They were grateful to Mr. F. Cleaver for his help at the organ. He had now taken up an appointment elsewhere. An organist was urgently needed.

Although resident in Badsey, the Vicar and Deaconess treated both parishes as one unit as far as visiting was concerned, and there was no preferential treatment for one or the other. During the past few months there had been a considerable number of newcomers in Wickhamford to be visited and welcomed.

Proposals were discussed for more effective church membership and an assured regular income to enable the P.C.C. to meet its commitments and obligations. These proposals were referred to the P.C.C. for working out at an early date.
