

#### THE VICAR'S LETTER

February 1988

My dear Friends,

We hear much today about the secular age and secular world in which we live. Generally speaking the word secular means 'of this age' 'of this world' as contrasted or compared with the sacred, monastic or ecclesiastical, which have to do with spiritual and religious values. Values not confined solely to this age or to this world.

In his book "God, Christ and the World" Archbishop Michael Ramsay writes: "Examples of such secularity come easily to mind. There is the widespread rejection of morality, and authority. There is a lack or even a loss of any sense of history. There is a belief in man's ability to satisfy all his needs through his own unaided efforts, especially in the field of technology. There is the rejection of that sense of another world beyond and before this one that influenced the outlook of earlier cultures and civilisations. And of course religious beliefs, practices and institutions are dismissed as devoid of any real relevance or meaning. For the secular person, this world, this temporal, physical world in which we live is the only world which exists. Eternity is irrelevant and meaningless. There are no human values which transcend this age and this world. In short, there is no sense of the eternal. Furthermore religion encourages people to resist scientific progress. The practice of prayer and worship draws people into an unreal realm of fantasy, and absorbs energies which should go into the world's proper business. True, man has his frustrations but his dignity lies in his power to overcome them, as he can through the right application of scientific knowledge to his needs. Religion gives not help but hindrances and it keeps man in a state of childish dependency and holds him back from his maturity".

This understanding of the secular as applied to the age and world in which we live goes a long way to understanding much of what is going on in the world around us, and the kind of influences being exerted upon the church and indeed upon all forms of religion. The secular influences the church is really up against. Yet, if anything, since Archbishop Ramsey first wrote these words some twenty years ago, there has been a swing back towards more fundamental religious attitudes. Whilst the influence of the secular seems to grow stronger, (observe how many people prefer to spend their Sundays nowadays) so too does man's reaction against it. Is not man perhaps becoming more conscious of the need to re-discover the true dimension to life rather than separate himself from it? A completely secular life only produces a spiritual vacuum which yearns to be filled.

This tension between the secular and the sacred, between the need to hold on to the things of God, to things eternal, yet at the same time to speak in meaningful terms and be relevant to the present age is seen in the church itself, and lies behind much of its recent troubles. On the one hand the church has been called out of the world, to be holy and separate and apart from the secular, yet at the same time its mission is to transform the secular as it prays "Thy will be done, on earth, as it is in heaven". It is a tension between trend and tradition, that has become very real.

What then might be the answer? Ifeel I can do no better than return to some more words of Archbishop Ramsey as he writes. "Our understanding of God needs openess . . . By openess to the past the Christian can contemplate the life, and death and Resurrection of Jesus . . . But the deepest significance of the past is that it contains reflections of what is eternal. Saintly men and women of any age belong to more than their own era; they 'transcend' it. Therefore openess to heaven is necessary . . ... because heaven is the final meaning of man as created in God's own image for lasting fellowship with God . . . But it is realized no less in every act of selflessness or humility or compassion, for such acts are already anticipations of heaven here and now . . . Thus our openess to heaven is null and void unless it carries with it an openess to the world around us. Within the daily decisions and relationships of the world around us we encounter God and we learn the meaning of God's love in human terms. Those who would isolate the secular from the past and from eternity lose the dimension in which human lives have their ultimate meaning and perspective. But equally those who would aspire devoutly to heaven without realising the anticipations of heaven to be found within the secular are aiding the false divide between the secular and the sacred which is the cause of so many ills . . . The Christian hope is always twofold, for the vision of God and for the coming of the reign of God in the world . . .

Such is the life with Christ and in Christ, who is at once the Man for others and true God".

Jesus gave us two great commanments. He said, "You shall love the Lord your God with all your heart, with all your soul, with all your mind, and with all your strength, and your neighbour as yourself". The secular world seems to ignore the first, whilst there are some within the church who seem to ignore the second. But the two commandments are really inseparable. For it is in the love of God that we love our neighbour, and it is in loving our neighbour that we love God. The secular person lives their life only in the present and for themselves. The spiritual person lives their life for others and for God.

#### Report of Badsey P.C.C. meeting on 7th January 1988

There was nothing further to report on the loss of the painting. A cheque had been received from our insurance company in settlement of our claim for this. Mr. Gregory was to contact the council again regarding disposal of church refuse on a regular basis in black sacks from the churchyard. Unfortunately, due to lack of support, the Sunday School was to stop as it was felt impractical to continue with so few children attending. The appeal fund now stood at £27,302 which was a marvellous effort by the Appeals Committee and the people of Badsey since the fund started. The church fete was to be held on 18th June 1988 and the Harvest Supper on 7th October 1988. A committee was to be set up to consider the whole question of church insurance. A tree surgeon was to be asked to deal with some dangerous branches in the churchyard.

#### Report of Wickhamford P.C.C. Meeting on January 13th.

The Vicar and Churchwardens had met the architect who had advised that the North Side of the Church roof had deteriorated. According to the records, the whole roof had been re-slated in 1954 by Mr. Savage of Badsey, and the architect at the time had reported that he was very pleased with the quality of workmanship. In view of this fact, it is unlikely that there can be anything seriously wrong. However, the P.C.C. agreed that, a closer inspection should be made by a professional slater to determine the condition of the roof beneath the slates as a first step.

A design for a Baptismal Candlestand by Mr. David Caswell was approved as a further memorial to Miss Alice Cox. A new ruling that named memorials would not be allowed in churches within 5 years of death was noted.

Fire extinguishers are to be installed in the church as recommended by the fire officer.

Following the new formula for allocation of Quota being implemented, Badsey faces a 12.3% increase and Wickhamford a small reduction of 5%. It was agreed that we should help Badsey to meet this amount by making a contribution towards their new allocation.

The Committee considered questions posed by the Archdeacon's Inquiry relating to various aspects of the Church and the Community. About a third of the adult people living in the village are of retiring age, and there is a definite decline of families with young children.

The Annual General Meeting will be held on March 9th, when it is hoped as many parishioners as possible will attend and give their views about any matters relating to the church.

#### WICKHAMFORD W.I.

The January meeting was very well attended and members and visitors were fascinated by the talk given by Mr. Paul Abbott of Evesham on his experience of supplying and making curtains and furnishing for the new palace in Brunei, which the Sultan was having built for one of his wives. Samples of the materials were passed around and very much admired. Mr. Abbott was thanked by Mrs. Sheena Beavan.

Volunteers were asked for in the task of supplying material for "The Worcestershire Book" which will give an insight into our village past and present. It is hoped that this will be published in time for Christmas 1988. The Annual Christmas Dinner will take place on Thursday 21st January in the Village Hall. The flower competition was won by Mrs. Peggy

Hancock and the February competition will be for a Hand-Made Valentine card.
