

THE VICAR'S LETTER

June 1990

My dear Friends

The Confirmation at Wickhamford will take place on Sunday, 24th June, the Patronal Festival of the church. It will be conducted by the Bishop of Dudley, Bishop Tony Dumper. Your prayers are especially asked for the eleven young candidates to be confirmed at this most important stage of their Christian life and faith.

To confirm means to strengthen, to make stronger and it is at confirmation that the faith and beliefs of the candidates is strengthened and made stronger to equip them for their life in the church and in the world. It is also the time when the promises made for them at their baptism are confirmed by the candidates themselves, and when the life of the church is strengthened by their admission into Holy Communion.

In the confirmation classes, we have been talking about the distinction between believing in something and having faith in something. How we believe that the sacraments represent the body and blood of Jesus by which we are sustained and nourished throughout our earthly pilgrimage but it is only when we receive and accept them in faith, believing in Jesus's sacrifice upon the Cross for our sakes, that they become an effective means of his saving grace and love towards us.

At their Confirmation the candidates enter fully upon the

family life of the church. It is appropriate therefore that their families should support them on this occasion and thereafter, and that the family of the church should join with them in doing so. For this reason your prayers are especially asked for the young candidates at this time.

On quite a different matter, may I draw the attention of parishioners and churchgoers of Badsey with Aldington to an article which appears elsewhere in this Review on Badsey Churchyard, which it is hoped will help people to understand a little better the present position concerning the churchyard.

BURIAL IN BADSEY CHURCHYARD

Every parishioner and person dying within the parish of Badsey with Aldington have the right to be buried in the churchyard if there is room. The same right exists for persons whose names were on the church electoral roll at the date of their deaths. Although in the case of persons who are not parishioners, nor on the electoral roll, nor die within the parish, there is no right to burial in the churchyard, permission may be given by the incumbent having regard to any general guidance given by the parochial church council of the church with respect to the matter. Such permission should be granted sparingly for it infringes the rights of the parishioners for whose interment the churchyard is primarily intended. In this connection it should be remembered that there are certain categories of persons, such as ex-parishioners and non-parishioners with family graves or vaults in the churchyard, or who have close relatives buried there, who may be regarded as almost having a customary right of burial and who deserve special concern and consideration.

The present position in Badsey Churchyard is that there are now only approximately thirty five to forty new burial places remaining before the churchyard is full, probably about five to six years from now. When this happens, application will be made for the closure of the churchyard. On being granted this will extinguish the rights of parishioners to be buried therein, other than in already existing graves or for the interment of cremated remains.

Since 1906, over 1000 interments, including the interment of cremated remains have taken place, and there are approximately 484 marked graves in the churchyard. There are therefore many ex-parishioners and non-parishioners with family graves or close relatives buried in the churchyard who may be said to be deserving of special concern and consideration. Whilst such special concern and consideration will always be given for a non-parochial burial to take place, and whenever possible permission granted, whenever such permission is granted it infringes upon the rights of present parishioners for whom the churchyard is primarily intended, namely those who need a burial ground close to where they live. This is the difficult choice that has to be made when deciding between the two, in a churchyard where space is already limited.

A Funeral Service, followed by cremation and the interment of cremated remains, either in the Garden of Remembrance or in an existing grave, or by burial elsewhere, either in another churchyard or a cemetery may take place at any time by arrangement with the family concerned.

REPORT OF WICKHAMFORD P.C.C. MEETING - MAY 9th

Preparations for the Flower Festival on August Bank Holiday are proceeding well with 25 gardens to be open. It was decided to leave painting the interior of the church until after the Flower Festival.

Mrs Collis reported on the Church's finances and raised a suggestion that a new effort to promote planned giving should be made. At present £230 a year was received from the Inland Revenue, a tax repayment from fourteen Covenants. The discovery of the clock which controls the meter for Economy 7 being $2\frac{1}{2}$ hrs out prevented an overcharge of nearly £100 on the quarterly electricity bill.

There will be a Week End Festival in October at Worcester based on discussion groups and social activities. A man, a woman and a young child are invited to attend from each parish to what is hoped to be an informative and enjoyable occasion. The Bishop of Durham will address the final session on the Sunday afternoon.

A proposal was received from Mrs Anne Poulter that an informal group meeting on a regular basis should be set up for the benefit of older Sunday School members. Due to the sharp decline in the number of children in the village it is increasingly difficult to maintain the Sunday School. Dr Astley praised Mrs Poulter and Mrs Collis for the work they have done and welcomed the proposal as a constructive suggestion.

The meeting fully supported any move to help and retain this age group who are the future of the church.

WICKHAMFORD GARDENING CLUB

The May meeting of the Gardening Club was well attended for a talk by Miss Rosamund Young entitled "Organic Farming". At Kite's Nest, Broadway, the Young family are passionately devoted to promoting organic farming, and their farm has been completely free of chemical treatments since 1966. With the use of colour slides, Miss Young explained that their cattle are much respected and live very contented lives. They have plenty of freedom and the cows live an average life of 20 years. The family also grow cereals, mill their own flour and ultimately bake their own bread. Miss Young answered several questions before being warmly thanked by the chairman, Mr Tom Hale.

The competition for "Any Pot-Plant" was jointly won by Mrs

Hale and Mrs Halling, with Mrs Dunkerley third.

The next meeting will be at 7.30 pm on Wednesday, 6 June, when Amanda Palant will talk on "Growing Herbs and their Uses in Medicine".
