# St James, Badsey with Aldington Parish Newsletter November 2003

One of the many changes which have occurred in our society over the past ten years is the increase in the powers and responsibilities given to School Governors. This includes managing the policy of a school budget set in hundreds of thousands or millions of pounds and most of the 'employers responsibilities towards the school staff. If a school fails its inspection, the Governors get sacked. The days of a termly chat over tea and cakes have long gone and being a School Governor can be a demanding task for which the only reward is the satisfaction of a job well done. In practice, this means that School Governors can often be hard to find and there are also a number of checks to ensure that those appointed are not disqualified or unsuitable.

Whilst most people have a free choice about whether they would like to become a Governor, many Church of England Clergy do not have that same choice. Whether I like it or not I have to be a Governor in Offenham and as a result the way in which I use a whole chunk of my time each week is out of my control. Keeping up with the Law at one school means that being a Governor at a second school is relatively simple and so I am also a Governor at Blackminster Middle School, where I meet pupils from all three of my parishes.

As it happens, I enjoy my work as a School Governor, and it enables me to keep in touch with a whole sector of the local population. It also means that I have an input, either directly or indirectly, into the ethos of the way in which the school is run. This is a very important function and relates directly to my role in the community.

Once each year, I am obliged to spend a day observing Mathematics Lessons at Blackminster. This is always an interesting experience. However, what makes this particularly interesting is the way in which the teaching of Mathematics to 11,12 &13 year olds has changed over the years. My scientific research background means that I find the actual mathematics itself easy. However, the techniques used to arrive at the answers are quite different to those which I use and which I therefore presume I was taught at a similar age. The content is the same but gone are the plain questions which bore no relation to real life. Almost everything is now taught in terms of the real questions of daily experience. Education is absolutely vital and a constructive input is one of the most valuable uses to which any of us can put our time

# CHURCH PECULIARITIES - PART 2 - THE CHURCH AND CHURCHYARD

The Vicar (or Rector) owns the Parish Church and the Churchyards as Freehold Property. In practice this means that the Vicar of Badsey with Aldington and Offenham and Bretforton owns the freehold of three Church buildings and three Churchyards. In practice the Church Councils are responsible for financing the maintenance of this property, but it does have a number of side effects. The first of these is that the Vicar also owns the freehold of all headstones and monuments which are placed in the Churchyard – indeed any fixture within the Churchyard boundary falls within this freehold. The second is that any changes to a Church building and the erection or modification of any monument in a Churchyard can only occur after a legal process known as Faculty Jurisdiction – to do otherwise means that both the Vicar and those making the change have committed an unlawful action as defined by Act of Parliament. In practice this means that the maintenance of the Church building or the addition of a new bookshelf requires legal permission. However, the same rules which make it an offence to add or modify any monument or fixture also makes it an offence to remove any monument.
